Request for an extension of the recording deadline for a minor final plat entitled "Walz Addition".

Background Information:

The plat of "Walz Addition" is located in Minden Township. The County Board granted a 60-day extension to record the final plat on June 19, 2019 due to issues with locating a blanket easement owned by Northern Natural Gas. The deadline to record the plat is August 18, 2019.

During the abstract and title opinion update and review, it was revealed that there was an ownership issue with the property that will need to be resolved prior to the Assistant County Attorney signing the plat and it being recorded.

The request is to split a 3 acre parcel from a 23.16 acre parcel (part of a 112.27 acre tract) for the construction of a single family home.

The Planning Commission reviewed and provided a recommendation of approval of the preliminary plat of Walz Addition on February 14, 2019 at a public hearing.

Attached is the owner/applicant request for a one-year extension to record the final plat and a memo from Assistant County Attorney Michelle Meyer's regarding the signing of the plat.
