REGULAR MEETING MINUTES
DECEMBER 19, 2023

The Benton County Human Services Board met in regular session on December 19, 2023, in the Benton County Board Room in Foley, MN with Board Members Beth Schlangen, Steve Heinen, Scott Johnson, Jared Gapinski and Ed Popp present. Call to order by Human Services Board Chair Steve Heinen was at 10:30 PM.

Motion by Gapinski and seconded by Popp to approve the agenda as written. Motion carried unanimously.

Johnson/Schlangen to approve Consent Agenda item 1 – 4: 1) to approve the Human Services Meeting Minutes of December 7, 2023 and authorize the Chair to sign; 2) approve the contract for Lighthouse Family Services to complete Benton County's required qualified individual assessments and authorize the Chair to sign; 3) approve the Medica Contract for Mental Health Targeted Case Management and authorize the Chair to sign; 4) approve the three separate Community Adult Mental Health Initiative (CAMHI) contracts and authorize the Chair to sign. Motion carried unanimously.

Next, Community Health Administrator Jaclyn Litfin requested the County Board to consider a Resolution to accept a donation from Medica to Benton County Public Health-Human Services. On 11/07/2023, the Benton County Board of Commissioners approved Public Health staff to apply for funding from Medica in the amount of \$5,000. Medica received the application, approved it, and remitted the funding in the amount of \$5,000. This funding will be used to purchase items intended to improve the quality of life for individuals served. Motion by Johnson and seconded by Gapinski to adopt the Resolution to accept a donation from Medica to Benton County Public Health-Human Services for \$5,000. Motion carried unanimously.

Next, Human Services Deputy Director Sandi Shoberg requested the County Board to appoint Victoria Blonigen as a representative to the St. Cloud Regional Homeless Task Force as a Benton County Provider. The City of St. Cloud is convening the Regional Homeless Task Force. Counties and cities were asked to appoint one representative to the task force. Social Services Supervisor Nikki Knowles was appointed at the November 7, 2023 Board Meeting. There was a recommendation to appoint Victoria Blonigen to the task force as the Homeless Outreach worker for Benton County. Motion by Johnson and seconded by Gapinski to appoint Victoria Blonigen as a representative to the St. Cloud Regional Homeless Task Force as a Benton County Provider. Motion carried unanimously.

Chair Heinen adjourned the meeting at 10:33 AM.

Update on Local Homeless Prevention Aid funding for 2023 and planning for 2024 allocation.


Background Information:

Local Homeless Prevention Aid was created by the 2021 Minnesota Legislature to help local governments ensure no child is homeless within a local jurisdiction by keeping families from losing housing and helping those experiencing homelessness find housing.
Benton County received an allocation of \$121,270 for 2023. This funding has been utilized in sustaining a family housing program with Lutheran Social Services and direct assistance to families in Benton County. (see attachment for funding allocations).
2023 allocations need to be fully spent by the end of 2024. Benton County does anticipate that funding will be fully spend by the end of the calendar year.
