The following described property situated in the County of Benton and State of Minnesota is zoned Business District "B":


That part of the Southwest Quarter of the Southwest Quarter (SW $\frac{1}{4}$  of SW $\frac{1}{4}$ ) of Section Twenty-eight (28), Township Thirty-eight (38) North, Range Thirty (30) West, Graham Township, Benton County, Minnesota, lying Southwest of State Highway Number 25 and Northwest of County Road Number 2.

BE IT FURTHER ORDAINED that this Ordinance be added to Appendix I of Ordinance Number 113, the Benton County Development Code.
