Northeast Corner of Section 32, Township 38 North, Range 29 West, Alberta Township,  
4<sup>th</sup> Principal Meridian, Benton County, Minnesota.

1855 Original US General Land Office survey set a wood post at this location and bearing trees were recorded.

12" Aspen	S 38 E	25 links
15" Aspen	N 33 1/2 W	35 links

No Date: County Surveyor's Record Book 2, page 301, shows a post at the corner.

1902 County Surveyor's Record Book A, Map No. 36, shows a survey of Section 33 by John Whilt. Survey shows a post at the corner location.

1940's Roll F-1, of MN/DOT road alignment records, File No. 12-80, note the corner is a fieldstone in center of roads west and north. The corner is 398.8 feet west of the P.I.

1981 Paul Wellen, LS 10461, found a 3/4" pipe and verified its location using Highway Map Information. He replaced it with a cast iron monument and filed Certificate of Location (#160211).

2003 Westwood Professional Services, Inc. found CIM.

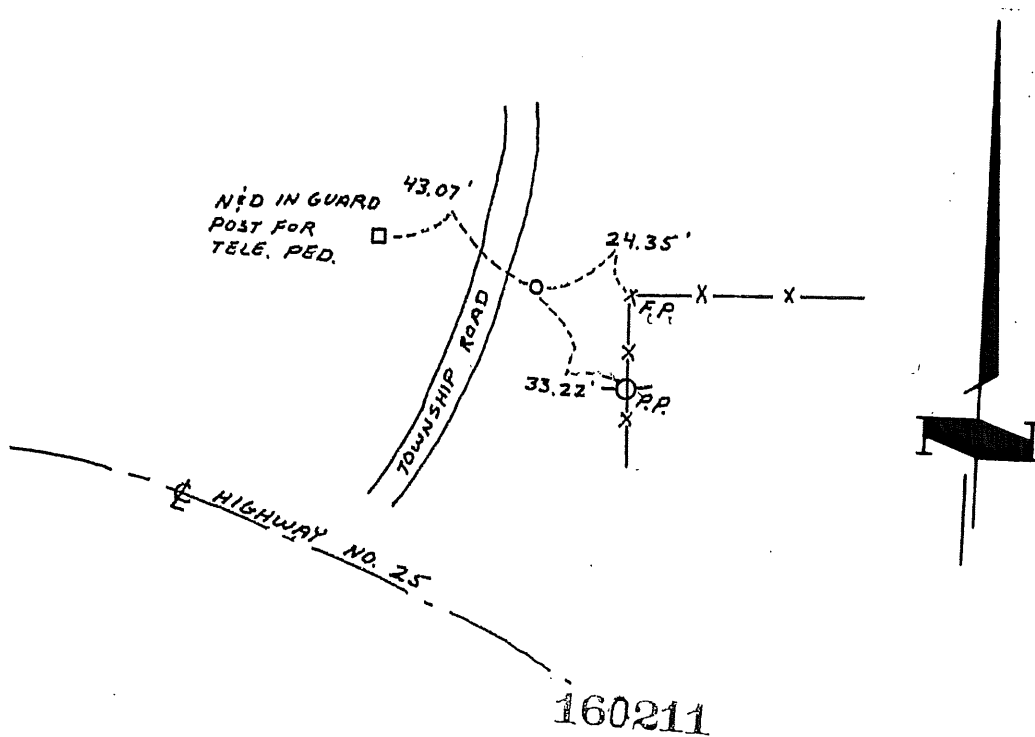
2008 Westwood Professional Services, Inc. found a cast iron monument at the corner location. CIM agrees with 1981 Wellen ties as shown on Doc. No. 160211. We search for the PI and any accessories to it and found no evidence. CIM measured 395.85 feet west of a computed PI location by locating the traveled road tangents which agrees favorably with 1940's MN/DOT alignment plans. In 2003 we searched by hand digging stone as shown on MN/DOT and found nothing in the search area. The alignment of 95<sup>th</sup> Ave. NE has changed significantly from the 1940's plan, and it appears as if a fair amount of earth moving had to be done when road was relocated as stone may have been destroyed. CIM is accepted as marking the obliterated position for this corner. Coordinates obtained by GPS coincide with our 2003 position.

2011 The Benton County Surveyor's Office placed a 1/2" by 14" iron pipe capped 19552 in place of the cast iron monument, which had been destroyed by road construction.
