The Northeast Corner of Section 23, Township 38 North, Range 28 West, Granite Ledge Township, 4th Principal Meridian, Benton County, Minnesota.

- 1855 Original US General Land Office surveyor, Oscar F. Davis, set a wood post at this location and bearing trees were recorded.

- 2000 Dennis Pederson, LS 16095, Bogart, Pederson & Associates, Ins. found a Mag Nail over an iron pipe previously set that fit with 1960 and 1972 County Highway records.
- 2003 Westwood Professional Services, Inc. found a Mag Nail in road. Ties to W.Oak NW and 1972 to PP NE fit well.

- 2012 The Benton County Surveyor's Office found the PK Nail flush with the road surface in the center of a 4-way road intersection. The found PK Nail fits the 1937 distances within 0.5 feet proportionally and falls in the intersection as called for in 1933. The PK Nail is accepted as the best available evidence of the corner location. The 2003 coordinates were verified.
